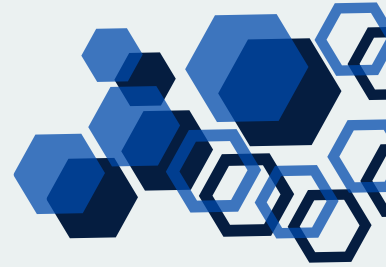

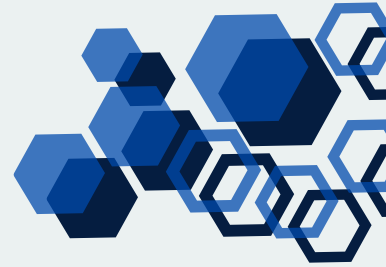
The GNLU Centre for Healthcare, Ethics, Legal Advocacy and Policy Research (G-HELP)



To provide a platform for the exchange of ideas, research findings, and best practices focused on balancing the rights and responsibilities of medical professionals and patients within India's healthcare system.

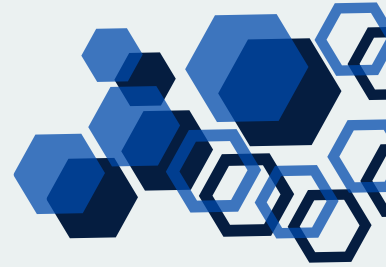


To identify and address critical issues and emerging trends in medical law, policy, and ethics, with an emphasis on legal protections and accountability for both healthcare providers and patients.

To contribute to the development of evidence-based legal frameworks and policies that protect patient rights, promote professional responsibility, and uphold ethical standards in healthcare practices.



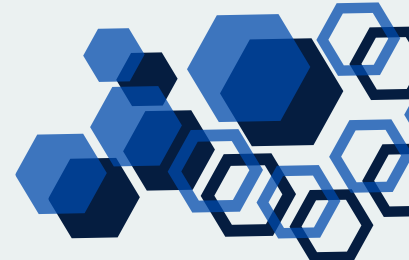
Eligibility

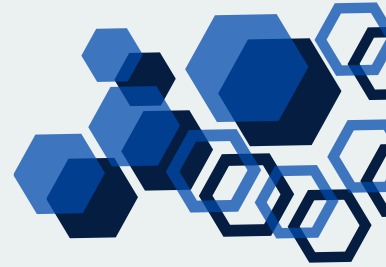
Legal Protection for Healthcare Providers

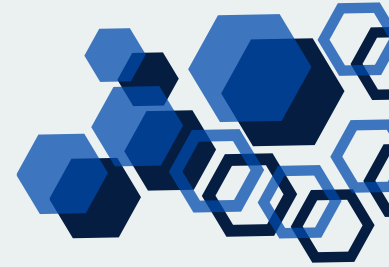

Paper Categories

1. **Research Articles:** Original research papers that present substantial contributions to the field.
2. **Review papers:** Comprehensive and critical analysis of existing research, theories, concepts, or practices within a specific field or topic.

Abstract Guidelines

Abstracts should be of **250-300 words** (to be submitted by **25th October 2024**). The abstract should clearly highlight the significance of the topic, objectives and methodology to be adopted for the conduction of the study along with **3-5 keywords**. Submissions should be in **English** only.
