One of the most significant committees in the college is the Moot Court Society.

ABOUT THE MOOT COURT SOCIETY

Law schools place a lot of emphasis on and revere Proust Moot Court contests, and for good reason. Through its portals, students can develop their advocacy abilities by simulating real-world legal practise and arguing real-world legal practise in fictitious instances. Additionally, mooting aids in the practise of court procedure because forensic practise is mostly oral. Developing arguing strategies, honing research techniques, exploring the various legal requirements and legal precedents, and broadening one's knowledge base are all required for participation in a moot.

In order to do this, freshmen admitted to the institution are immediately provided initiation into a Demo Moot within a week of their admission. The college has made an effort to offer a private Moot Court auditorium that is an exact replica of a courtroom, including a raised dais for the judge/bench, witness stands, prosecution/defense/litigant table, and the bar. They can compete in regional, national, and international contests thanks to this platform. The annual Intra Moot Competition is an illustration of the enthusiasm that mooting generates.

ABOUT THE 12TH EDITION

The Moot Court Society of SVKM's Pravin Gandhi College of Law hosts the National Trial Advocacy Competition. The ardour among the competitors and onlookers changes over the course of the three-day event. The Bench for the Final Round of the 12th Edition comprised of Hon'ble Justice (Rtd.) U. D Salvi and Hon'ble Justice (Rtd.) Anand Potdar. The team from School of Excellence in Law College, Tamil Nadu lifted the Winning Trophy and the team from Thakur Ramnarayan College of Law, Mumbai secured the Runners Up position.
